## RULES AND REGULATIONS

1. Power Entertainment, its subsidiaries and affiliated organizations (the "Organizer") will conduct "The Music Game Playin To Win Seminar & Showcase" (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:
2. Participants must register at [www.themusicgamebook.com](http://www.themusicgamebook.com) or at participating affiliate location. A one-time \$125.00 registration fee is required for the Contest. Power Entertainment will accept money orders, credit card, or cash for the registration fee (checks will not be accepted). Registration fees are nonrefundable and non-transferable.
3. The Contest is not open to professional singers or performers; no participant contracted under a recording and/or production deal may participate in the contest. Participants less than 18 years of age must be accompanied by a parent or legal guardian. No group may exceed more than 4 people.
4. Power Entertainment will not be responsible for any copyrighted or non-copyrighted material or any infringements by any participants.
5. Participants may only perform to CD track, piano/keyboard (no band performance allowed).
6. Judging will take place before a professional panel on performance and stage presence, on a scale of 1-10. Finalists will perform before a 5-10 judge panel. The grand prize winner will be the finalist whose performance received the highest score.
7. Release. By participating in the Contest, each participant and winner waives any and all claims of liability against Power Entertainment, its employees and agents, directors, the Contest's sponsors and their respective employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the Contest, or from the use of any prize. In order to receive a prize, participants must sign an official waiver form provided by Power Entertainment.
8. Taxes. Any valuation of the prize(s) stated above is based on available information provided to Power Entertainment, and the value of any prize awarded to a winner may be reported for tax purposes as required by law.
